**WHEREAS**, the above designation need be made in compliance with the Open Public Meetings act, "N.J.S.A. 10:4-6, et seq." providing for public notice of all meetings of the Planning Board.


**NOW, THEREFORE, BE IT RESOLVED**, by the Washington Township Planning Board as follows:

1. The public notice bulletin board of the Township Municipal Building is hereby designated as the place for posting notice of regular, special or rescheduled meetings of the Planning Board.

2. The South Jersey Times and Courier Post are hereby designated by the Planning Board to receive notices of regular, special or rescheduled meetings, because they have the greatest likelihood of informing the public within the area of Washington Township.
