**RESOLUTION OF THE TOWNSHIP OF WASHINGTON PLANNING BOARD
AUTHORIZING AGREEMENT FOR PROFESSIONAL SERVICES FOR THE YEAR
2020 (SOLICITOR)**

WHEREAS, there exists a need for a Solicitor to provide legal services for the Washington Township Planning Board; and

WHEREAS, the Washington Township Planning Board has been granted the power to retain the services of a Solicitor and the funds are available for the employment of a Solicitor; and

WHEREAS, Timothy Scaffidi Esquire, is an attorney licensed to practice law in the State of New Jersey and is willing and able to act as Solicitor for the Washington Township Planning Board; and

NOW, THEREFORE, BE IT RESOLVED, by the Washington Township Planning Board as follows:

1. Timothy Scaffidi Esquire, be and is hereby appointed as Solicitor for the Washington Township Planning Board to perform legal services from January 1, 2020 to December 31, 2020.
2. Said duties, terms and conditions of employment for the Solicitor of the Washington Township Planning Board shall be in accordance with those specified in an agreement executed by the respective parties.
