**RESOLUTION OF THE TOWNSHIP OF WASHINGTON PLANNING BOARD
AUTHORIZING AGREEMENT FOR PROFESSIONAL SERVICES FOR THE YEAR
2020 (PLANNER)**

WHEREAS, there exists a need for a Planner to provide planning services for the Washington Township Planning Board; and

WHEREAS, the Washington Township Planning Board has been granted the power to retain the services of a Planner and the funds are available for the employment of a Planner; and

WHEREAS, Joseph Petrongolo - Rd V is a planner licensed to practice in the State of New Jersey and is willing and able to act as Planner for the Washington Township Planning Board; and

NOW, THEREFORE, BE IT RESOLVED, by the Washington Township Planning Board as follows:

1. Joseph Petrongolo - Rd V be and is hereby appointed as Planner for the Washington Township Planning Board to perform planning services from January 1, 2020, up to and including December 31, 2020.
2. Said duties, terms and conditions of employment for the Planner of the Washington Township Planning Board shall be in accordance with those specified in an agreement executed by the respective parties.
