**ORDINANCE AUTHORIZING AN AGREEMENT FOR TAX ABATEMENT WITH
PROVCO SICKLERVILLE, LLC FOR THE PROPERTY KNOWN AS BLOCK 108.02, LOT 1.02**

WHEREAS, Provco Sicklerville, LLC, filed an application for a short-term (5 year) tax abatement with the Township for the property known as Block 108.02, Lot 1.02: and

WHEREAS, the application for the tax abatement was submitted on September 17, 2019 to the Clerk’s Office, in furtherance of which the Township Tax Collector was requested to, and did review, the application for compliance with State statute and Township Code; and

WHEREAS, the Tax Collector has deemed the application complete, found that it satisfies all requirements and has recommended this property for admission into the short-term tax abatement program.

NOW, THEREFORE, BE IT ORDAINED, by the Township Council of the Township of Washington, County of Gloucester, State of New Jersey, that it hereby approves the tax abatement and authorizes the Mayor and Township Clerk to execute an agreement for tax abatement pursuant to N.J.S.A. 40A:21-1, et. Seq., and Township Ordinance Chapter 229 with Provco Sicklerville, LLC for the property known as Block 108.02, Lot 1.02 on the Township Tax Map for the use of said property 3421 Route 42, Washington Township, New Jersey 08012.

This Ordinance shall take effect thirty (30) days after final passage by Council or twenty (20) days after approval by the Mayor, whichever comes first.






