

**ORDINANCE 25 – 216**

**WASHINGTON TOWNSHIP  
GLOUCESTER COUNTY**

**ORDINANCE AMENDING CHAPTER 260 OF THE CODE OF THE TOWNSHIP OF  
WASHINGTON (VEHICLES AND TRAFFIC) IN ORDER TO PROHIBIT RIGHT  
TURNS ONTO LAMBS ROAD WHILE TRAVELING WESTBOUND ON BETHEL  
MILL ROAD**

WHEREAS, Chapter 260 of the Code of the Township of Washington regulates stopping, standing, parking and movement of vehicles in the Township; and

WHEREAS, Chapter 260-28 lists turns which are prohibited at certain intersections by any truck, tractor, semi-trailer, or omni-bus having a registered gross weight in excess of four (4) tons; and

WHEREAS, it has been determined that right turns onto Lambs Road by vehicles westbound on Bethel Mill Road should be prohibited.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Washington that the following should be added to Chapter 260-28 of the Township Code:

**Intersection**

**Turn Prohibited**

Bethel Mill Road  
and Lambs Road (CR635)

Right Turn onto Lambs Road (CR 635)  
while traveling westbound on Bethel Mill  
Road by any truck, tractor, semi-  
trailer, or omni-bus having a registered  
gross weight in excess of four (4) tons

This Ordinance shall take effect thirty (30) days after final passage by Council or twenty (20) days after approval by the Mayor, whichever comes first and the installation of appropriate signage.
