**ORDINANCE HONORING FRANCIS J. CAMPBELL, JR BY ASSIGNING THE
ALTERNATE NAME OF FRANK CAMPBELL BOULEVARD TO MCCLURE
DRIVE**

WHEREAS, Francis J. Campbell Jr. (Frank) was a long tenured loyal employee of the Township of Washington having served in various capacities since 1987; and

WHEREAS, Frank began his Washington Township career as an auto and truck mechanic and thereafter was promoted to the supervisory position of Head Mechanic. Thereafter he assumed the position of Public Works Supervisor and also served as Washington Township Emergency Management Coordinator; and

WHEREAS, in addition to his employment in Washington Township Frank was extremely involved in community activities and causes. Among other things he was involved with his church, the Knights of Columbus, politics and various community organizations. He was involved in fundraising for many charitable causes and was always available to help anyone in need; and

WHEREAS, Frank passed away in December of 2014 after a long and courageous battle with cancer; and

WHEREAS, the government of Washington Township and its residents are deeply indebted to Frank for his services as an employee and contributions as a member of the community;

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Washington that as a lasting tribute to Francis J. Campbell, Jr. MCCLURE DRIVE is hereby assigned the alternate name of **FRANK CAMPBELL BOULEVARD**;

BE IT FURTHER RESOLVED that the Mayor is hereby authorized to cause the appropriate signage to be erected in memorialization of this honor.

This Ordinance shall take effect thirty (30) days after final passage by Council or twenty (20) days after approval by the Mayor, whichever comes first.
