

**ORDINANCE 08 - 2016**

**ORDINANCE FIXING THE SALARIES OF CERTAIN OFFICERS AND EMPLOYEES OF THE TOWNSHIP OF WASHINGTON**

**BE IT ORDAINED**, by the Township Council of the Township of Washington, County of Gloucester, and State of New Jersey as follows:
