

ORDINANCE 006 - 2017

**WASHINGTON TOWNSHIP
GLOUCESTER COUNTY**

**ORDINANCE AMENDING SECTION 260-25 OF THE CODE OF THE
TOWNSHIP OF WASHINGTON ENTITLED "STOP INTERSECTIONS"**

WHEREAS, Section 260-25 of the Code of the Township of Washington designates certain street intersections as "stop intersections" and Section 260-27 of the Code designates certain street intersections as "yield intersections" pursuant to N.J.S.A. 39:4-140; and

WHEREAS, the Mayor and Council of the Township of Washington authorized the Township Engineer to conduct a study and render an analysis regarding the suitability and/or necessity for stop or yield traffic controls at certain intersections along Greenleigh Drive and John Drive; and

WHEREAS, the Township Engineer has recommended certain intersections along both roadways be designated as "stop" intersections and further recommended that certain intersections along Greenleigh Drive be designated as "yield" intersections in accordance with applicable standards set forth in the Manual on Uniform Traffic Control Devices for Streets and Highways; and

WHEREAS, pursuant to N.J.S.A. 40:48-2, the Governing Body is authorized to enact and amend ordinances as deemed necessary for the preservation of the public health, safety and welfare and as may be necessary to carry into effect the powers and duties conferred and imposed upon the Township by law; and

NOW THEREFORE, BE IT ORDAINED by the Township Council of the Township of Washington, in the County of Gloucester, State of New Jersey, as follows:

SECTION 1: Section 260-25 of the Code of the Township of Washington, entitled "Stop Intersections," shall be and is hereby revised, amended and/or supplemented by adding the following to the list of designated stop intersections:

Northwesterly Intersection of Greenleigh Drive and Peak Place	Peak Place
Southeasterly Intersection of Greenleigh Drive and Peak Place	Peak Place
Northeasterly Intersection of Greenleigh Drive and Greenleigh Circle	Greenleigh Circle
John Drive and Village Court	Village Court
John Drive and John Court	John Court
Northerly Intersection of Greenleigh Drive and John Drive	John Drive
Southerly Intersection of Greenleigh Drive and John Drive	Greenleigh Drive
Peak Place and Skelly Lane	Skelly Lane

SECTION 2: Section 260-27 of the Code of the Township of Washington, entitled "Yield Intersections," shall be and is hereby revised, amended and/or supplemented by adding the following to the list of designated yield intersections:

<u>Intersection</u>	<u>Yield Sign on:</u>
Greenleigh Drive and Ridge Court	Ridge Court
Southwesterly Intersection of Greenleigh Drive and Greenleigh Circle	Greenleigh Circle
Greenleigh Drive and Knoll Court	Knoll Court

SECTION 3: Except as set forth in Sections 1 and 2 above, the balance of Sections 260-25 and 260-27 of the Code of the Township of Washington shall not be affected by this Ordinance.

SECTION 4: All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

SECTION 5: If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

SECTION 6: This Ordinance shall take effect thirty (30) days after final passage by Council or twenty (20) days after approval by the Mayor, whichever comes first.


