ORDINANCE AMENDING A CHAPTER OF THE CODE OF THE TOWNSHIP OF
WASHINGTON, CHAPTER 260 - VEHICLES AND TRAFFIC-STAGE COACH ROAD

WHEREAS, Chapter 260 of the Code of the Township of Washington regulates speed limits; and

WHEREAS, Township Council desires to amend said Chapter to amend the speed limit on Stage Coach Road to a lower limit as more particularly described below; and

WHEREAS, the Township of Washington Police Department and the Township Engineer have reviewed the location and determined that the area is appropriate for the speed of 35 MPH based upon a speed study for 35 miles per hour.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Washington, County of Gloucester, and State of New Jersey, that Chapter 260 Section 33 the two items for Stage Coach Road is hereby deleted and replaced with the following and hereby adopted:

Name of Street	Speed Limit	Limits
Stage Coach Road	35	From Whitman Drive to E Black Horse Pike

If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

This Ordinance shall take effect thirty (30) days after final passage by Council or twenty (20) days after approval by the Mayor, whichever comes first.




