**ORDINANCE AMENDING ORDINANCE 25-2017 OF WASHINGTON TOWNSHIP OF THE
CHAPTER 260-VEHICLE AND TRAFFIC ON PRIVATE PROPERTY**

WHEREAS, Ordinance 25-2017 amended Chapter 260-Vehicles and Traffic on Private Property; and

WHEREAS, the Township of Washington with the Mayor concurring adopted the Ordinance 25-2017 with the changes as listed; and

WHEREAS, the Township of Washington as a result of an oversight missed additional changes; and

WHEREAS, the Township of Washington feel the most expedient and efficient way is to amend the adopted Ordinance 25-2017.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Washington in the County of Gloucester, State of New Jersey, that Ordinance 25-2017 amending Chapter 260 of the Code of Washington Township is hereby amended, revised, and/or supplemented as follows:

SECTION 1: Article VIII Traffic and Parking Control on Public Private Property, § 260-48 E (1) shall be deleted and replaced with:

“(1) In the interest of public safety, the Township of Washington authorizes the application and implementation of Title 39 of the New Jersey motor vehicle statues as authorized by N.J.S.A. 39:5A-1 to all streets within Pinnacle Place and the Villages at Parke Place and specifically identified as follows:

- **Meridian Lane**
- **Pinnacle Place**
- **Tower Lane**
- **Belfry Place**
- **Spire Place**
- **Paladin Place**
- **Regency Place ”**

SECTION 2: Article VIII Traffic and Parking Control on Public Private Property, § 260-48 E (3) (a) shall be deleted and replaced with:

“(a)Parking:

- 1). **All vehicles must park in designated parking areas only and between the lines provided. In addition, the following restrictions apply:**
- 2). **No on-street parking along any curb lines that are not within the designated parking areas as shown on the approved development plans: (Planning Board Resolution 2015-16) entitled Pinnacle Place dated April 10, 2014 revised to May 21, 2017 prepared Consulting Engineering Services. (Planning Board Resolution 2014-10) entitled Parke Place Townhomes – Section 15 dated July 24, 2014 prepared by Consulting Engineering Services and “**

SECTION 3. Article VIII Traffic and Parking Control on Public Private Property, § 260-48 E (3) (e) shall be deleted and replaced with:

“ (e)STOP Controlled Intersections

The intersections described are hereby designated Stop intersections. Stop signs shall be installed as provided therein.

Regency Place & Paladin Place	Paladin Place
Regency Place, Paladin Place & South Access Drive	South Access Drive

SECTION 4: Except is set forth in Section 1 to 3 above, the balance of Ordinance 25-2017, and the balance of the Code of the Township of Washington, shall not be affected by this Ordinance.

SECTION 5: All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

SECTION 6: If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

SECTION 7: This Ordinance shall take effect thirty (30) days after final passage by Council or twenty (20) days after approval by the Mayor, whichever comes first.






