**REINTRODUCING AN ORDINANCE AMENDING A CHAPTER OF THE CODE OF THE  
TOWNSHIP OF WASHINGTON,  
CHAPTER 260 - VEHICLES AND TRAFFIC-SALINA ROAD**

**WHEREAS**, Chapter 260 of the Code of the Township of Washington regulates speed limits; and

**WHEREAS**, Township Council desires to amend said Chapter to amend the speed limit on Salina Road to an adjusted limit as more particularly described below; and

**WHEREAS**, the Township of Washington Police Department and the Township engineer have reviewed the location;

**WHEREAS**, after review with Township Engineer the Washington Township Police Department has determined that the area is not appropriate for the current speed of 25 miles per hour. They have determined an appropriate speed of 30 MPH.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Washington, County of Gloucester, and State of New Jersey, that Chapter 260 Section 33 the one item for Salina Road is hereby deleted and replaced with the following and hereby adopted:

If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.


This Ordinance shall take effect thirty (30) days after final passage by Council or twenty (20) days after approval by the Mayor, whichever comes first.




