**ORDINANCE ADOPTING AN AMENDED EMPLOYEE POLICIES AND PROCEDURES
MANUAL FOR THE TOWNSHIP OF WASHINGTON**

WHEREAS, the most recent version of the Employee Policies and Procedures Manual was adopted on November 22, 2016, by Ordinance Number 26-2016; and

WHEREAS, the Township Administration and Labor Counsel have recommended certain revisions to the Manual involving, among other things, drug and alcohol screening and background checks; and

WHEREAS, the proposed amendments/modifications are outlined in Attachment A to this Ordinance;

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Washington, County of Gloucester, State of New Jersey, that the Employee Policies and Procedures Manual shall be amended as provided for in Attachment A and is hereby adopted as amended in accordance therewith; and

BE IT FUTHER ORDAINED that a copy of the Employee Policies and Procedures Manual be distributed to all current Township employees and a copy shall remain on file in the office of the Township Clerk.

All ordinances or parts of ordinances of the Township of Washington heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of the inconsistency.

This Ordinance shall take effect thirty (30) days after final passage by Council or twenty (20) days after approval by the Mayor, whichever comes first.




