

ORDINANCE 16 - 2018

**WASHINGTON TOWNSHIP
GLOUCESTER COUNTY**

**ORDINANCE AMENDING CHAPTER 260 ARTICLE II OF THE CODE OF THE TOWNSHIP OF
WASHINGTON ENTITLED "STOPPING, STANDING AND PARKING"**

WHEREAS, Chapter 260, Article II of the Code of the Township of Washington regulates Parking prohibited at all times on certain streets; and

WHEREAS, there exists a need to amend and add a new no parking area ;

NOW THEREFORE, BE IT ORDAINED by the Township Council of the Township of Washington, in the County of Gloucester, State of New Jersey, that Chapter 260, Article II of the Code of Washington Township is hereby amended, revised, and/or supplemented as follows:

SECTION 1: Section 260-14 with as follows:

Name of Street	Side	Location
Whitman Drive	East	From a point in the easterly curblineline of Whitman Drive, which point is at the intersection of such curblineline with the prolongation of the southerly curblineline of Laurel Street, and extending northwardly 775 feet, more or less, to the southerly property ` line of <u>150 Whitman Drive</u> , Lot 12, Block 231

SECTION 2: Regulatory signs conforming to the current Manual on Uniform Traffic Control Devices for Street and Highways, (current edition) shall be erected and maintained at the above-designated locations.


SECTION 3: Except is set forth in Sections 1 above, the balance of Chapter 260, Article II, and the balance of the Code of the Township of Washington, shall not be affected by this Ordinance.

SECTION 4: All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

SECTION 5: If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.


SECTION 6: This Ordinance shall take effect thirty (30) days after final passage by Council or twenty (20) days after approval by the Mayor, whichever comes first.


