

ORDINANCE 0003-2020

WASHINGTON TOWNSHIP
GLOUCESTER COUNTY

AN ORDINANCE OF THE TOWNSHIP OF WASHINGTON, IN THE COUNTY OF GLOUCESTER,
STATE OF NEW JERSEY, APPROPRIATING CERTAIN MONIES FROM THE CAPITAL FUND
BALANCE ACCOUNT AND PROVIDING FOR CAPITAL UPGRADES AND ACQUISITION OF
VARIOUS POLICE TRAFFIC RELATED EQUIPMENT IMPROVEMENTS

*BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF WASHINGTON, IN
THE COUNTY OF GLOUCESTER, STATE OF NEW JERSEY* (not less than two-thirds of all members
thereof affirmatively concurring) as follows:

Section 1. The improvements or purposes described in this capital ordinance are hereby authorized to be undertaken by the Township of Washington, in the County of Gloucester, State of New Jersey (the "Township") as general improvements. For the improvements or purposes described thereof from the Township's Capital Fund Balance, there is hereby appropriated the respective sum amounting in the aggregate to \$100,000.

Purpose. Improvements and acquisition of various police traffic related equipment improvements, together with the acquisition of all materials and equipment of all work necessary therefor and incidental thereto.

Appropriation. \$100,000.00

Section 2. The several improvements or purposes described in this capital ordinance are not current expenses. They are improvements or purposes the Township may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.

Section 3. The capital budget or temporary capital budget (as applicable) of the Township is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or amended temporary capital budget (as applicable) and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section 4. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law.

Section 5. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law.
