ORDINANCE NUMBER 36-2006

WASHINGTON TOWNSHIP
GLOUCESTER COUNTY

ORDINANCE AMENDING CHAPTER 80, FEES, OF THE TOWNSHIP CODE
OF THE TOWNSHIP OF WASHINGTON

WHEREAS, the Township Council of the Township of Washington seeks to amend its fee ordinance in order to establish a fee schedule which adequately reflects the time expended and professional service rendered by the Township of Washington regarding certain zoning permits issued by said department; and to establish reasonable fees for applicants of said permits.

BE IT ORDAINED, by the Township Council of the Township of Washington, County of Gloucester and State of New Jersey that Chapter 80 Fees, § 80-41 is hereby amended as follows:

§ 80-41. Zoning Board of Adjustment fees.

D. Zoning permit fees shall be \$25.00 generally, except for the following specific permits:

- (1) Fences \$35.00
- (2) Sheds up to 200 sq ft \$35.00
- (3) Above ground pool \$35.00
- (4) Patios \$35.00
- (5) Change of Use/Occupancy/Ownership \$35.00
- (6) Signs \$35.00
- (7) Temporary Signs & Banners \$35.00
- (8) Temporary Tents \$35.00
- (9) Driveways \$35.00
- (10) Temporary Trailer \$35.00
- (11) Decks \$50.00
- (12) Retaining Wall \$50.00
- (13) Inground Pool \$75.00
- (14) Fit Outs \$75.00
- (15) Garage & Sheds over 200 sq. ft. \$75.00

- (16) Mobile Home Replacement \$75.00
- (17) Additions (sunrooms, porch enclosures, bedrooms, baths) \$75.00
- (18) Single Family Dwellings \$150.00
- (19) New Commercial Construction \$200.00

BE IT FURTHER ORDAINED that this Ordinance will take effect after adoption and publication according to law.

This Ordinance shall take effect thirty (30) days after final passage by Council or twenty (20) days after approval by the Mayor, whichever comes first.
