**RESOLUTION CONSENTING TO THE APPOINTMENT OF CONNOR STRONG AND BUCKELEW COMPANIES, LLC AS CONSULTANT/INSURANCE BROKER OF RECORD FOR EMPLOYEE BENEFIT PROGRAM RELATED TO MEDICAL, DENTAL, VISION, PRESCRIPTION DRUGS AND LIFE INSURANCE AND AUTHORIZING THE PROPER OFFICIALS TO EXECUTE AN AGREEMENT FOR PROFESSIONAL SERVICES FOR A TERM OF ONE (1) YEAR**

*WHEREAS*, the Township of Washington desires to appoint **Connor Strong and Buckelew, Companies, LLC**, as the Consultant/Insurance Broker of Record for its Employee Health Insurance Coverage/Employee Program related to medical, dental, vision, prescription drugs and life insurance; and

*WHEREAS*, the Local Public Contracts Law N.J.S.A. 40:11-1 et seq. requires that the resolution authorizing the award of contracts for "Professional Services" without competitive bids must be advertised; and

*WHEREAS*, this contract is awarded in accordance with the Fair and Open procedures as established in the "Pay to Play" Law N.J.S.A. 19:44A-20.5 et seq.; and

*WHEREAS*, the Township Council of the Township of Washington, Gloucester County, State of New Jersey hereby consents to the appointment of **Connor Strong and Buckelew Companies, LLC**, as Consultant/ Insurance Broker of Record for the Township of Washington.

*NOW, THEREFORE, BE IT FURTHER RESOLVED* by the Township Council of the Township of Washington, County of Gloucester and State of New Jersey that:



2. The contract period shall be from January 1, 2021 to December 31, 2021 not to exceed \$25,000.00.
3. The CFO has certified that funds are available in the 2021 budget in line item #1-01-23-220-000-001, entitled Other Insurance Premiums.
4. Notice of the contract award shall be published in the South Jersey Times.
