RESOLUTION CONSENTING TO THE APPOINTMENT OF NANCY MOZZACHIO AS ECONOMIC DEVELOPMENT CONSULTANT AND AUTHORIZING THE PROPER OFFICIALS TO EXECUTE AN AGREEMENT FOR PROFESSIONAL SERVICES FOR A TERM OF ONE (1) YEAR

WHEREAS, the Township of Washington recognized a need for an Economic Consultant for the Township Development; and

WHEREAS, the Township Committee and the Economic Development committee members acknowledge there is a continued need for Economic Development in the Township of Washington; and

WHEREAS, the Local Public Contracts Law N.J.S.A. 40:11-1 et seq. requires that the resolution authorizing the award of contracts for "Professional Services" without competitive bids must be advertised; and

WHEREAS, this contract is awarded in accordance with the Fair and Open procedures as established in the "Pay to Play" Law N.J.S.A. 19:44A-20.5 et seq.; and

WHEREAS, the Township Council of the Township of Washington in the County of Gloucester, State of New Jersey consents to the appointment by Mayor Gattinelli, that **Nancy Mozzachio**, Managing Principal at Sine Qua Non is hereby appointed the Economic Development Consultant for the Township of Washington.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Washington, County of Gloucester and State of New Jersey that:

1. The Mayor has been authorized to sign a contract with **Nancy Mozzachio**, Managing Principal of Sine Qua Non, 18 Quail Hollow Drive, Sewell, NJ 08080, on behalf of the Township of Washington, contingent upon the review and approval of the Township Solicitor
2. The contract period shall be from January 1, 2021 to December 31, 2021 not to exceed \$62,000.00.
3. The CFO has certified that funds are available in the 2021 budget in line item #1-01-20-170-000-299, entitled Board of Economic Development – Miscellaneous.
4. Notice of the contract award shall be published in the South Jersey Times.

BE IT FINALLY RESOLVED, that copy of this Resolution is to be provided to the Administrator, CFO, Economic Development Committee, and the Appointee.
