RESOLUTION AUTHORIZING CHANGE ORDER NO. 1 FINAL AND ACCEPTING A MAINTENANCE BOND FOR CONGRESS DRIVE ROADWAY IMPROVEMENTS, PROJECT #08-18-T-393

**WHEREAS**, Lexa Concrete, LLC, 11 Commerce Way Drive, Hammonton, NJ 08037 was selected by Township Council in accordance with Resolution R098-2020 for Congress Drive Roadway Improvements, Project #08-18-T-393; and

**WHEREAS**, Lexa Concrete, LLC, 11 Commerce Way Drive, Hammonton, NJ 08037 submitted a bid in the amount of \$293,666.50 and an agreement was signed by the Mayor; and

**WHEREAS**, Change Order No. 1 Final for Congress Drive Roadway Improvements was submitted by Township Engineer, Annina Hogan of Remington & Vernick, in a letter dated January 8, 2021 with a decrease of \$39,337.65, bringing the new total to \$254,328.85; and


**WHEREAS**, Lexa Concrete, LLC, 11 Commerce Way Drive, Hammonton, NJ 08037 has posted a Maintenance Bond in the amount of \$254,328.85.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Washington, County of Gloucester, and State of New Jersey that said Change Order No. 1 Final is approved and authorized for the new contractual total of \$254,328.85.
