**RESOLUTION AUTHORIZING THE CONTINUING OPERATION  
OF THE GREEN TEAM ADVISORY COMMITTEE**

**WHEREAS**, the Township Council of the Township of Washington strives to save tax dollars, assure clean air and water, improve working and living environments to build a community that is sustainable economically, environmentally, and socially; and

**WHEREAS**, the Township Council acknowledges that the residents of the Township of Washington desire a stable, sustainable future for themselves and for future generations; and

**WHEREAS**, the Township Council has created the Green Team Advisory Committee to advise the Mayor and Council on ways to improve municipal operations with "green" initiatives, and to facilitate focusing on issues that help to assure a sustainable future; and

**WHEREAS**, the Green Team Advisory Committee consists of up to eleven members, who are residents or employees of the Township of Washington, and who represent the Administration, Council, Environmental Commission, Planning Board, Municipal Utilities Authority, Chamber of Commerce, School Board, Public Works, and the Public; and

**WHEREAS**, the Green Team Advisory Committee has worked diligently and has successfully developed and implemented a plan by which the Township of Washington achieved silver-level certification by the Sustainable Jersey program in 2017, including performance and documentation of existing and proposed actions and activities.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of Washington, that the Green Team Advisory Committee continue operation through December 2021.

**BE IT FURTHER RESOLVED**, by the Township Council of the Township of Washington, that the Green Team Advisory Committee is directed to continue its efforts to advise the Mayor and Council of initiatives and activities that contribute to environmental, economic and social sustainability for the Township of Washington.

**BE IT FINALLY RESOLVED**, by the Township Council of the Township of Washington, that the Green Team Advisory Committee work to maintain the Township's silver-level certification by the Sustainable Jersey program and pursue actions to achieve silver-level certification in 2021.
