**RESOLUTION AUTHORIZING A CHANGE ORDER AND ACCEPTING A MAINTENANCE BOND
FROM THINK PAVERS FOR FY2019 NJDOT – HURFFVILLE ROAD IMPROVEMENTS,
PROJECT #08-18-T-385.i**

WHEREAS, Think Pavers, 125 Kings Highway, Mount Royal, NJ 08061 was selected by Township Council in accordance with Resolution R076-2020 for FY2019 NJDOT – Hurffville Road Improvements, Project #08-18-T-385.i in the amount of \$235,130.00; and

WHEREAS, Change Order No. 1 Final for FY2019 NJDOT – Hurffville Road Improvements was approved by Township Council in accordance with Resolution R212-2020 with a decrease of \$18,006.90, bringing the new total to \$217,123.10; and

WHEREAS, an additional change order was submitted with Certificate No. 3 Final for FY2019 NJDOT – Hurffville Road Improvements with a decrease of \$302.95, and

WHEREAS, in a letter dated March 3, 2021 from the Township Engineer, Remington and Vernick, has recommended that a Maintenance Bond be posted in the amount of \$217,123.10 for the FY2019 NJDOT – Hurffville Road Improvements, Project #08-18-T-385.i; and

WHEREAS, Think Pavers, 125 Kings Highway, Mount Royal, NJ 08061 has submitted Maintenance Bond #BX06807MB in the amount of \$217,123.10.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Washington, County of Gloucester, State of New Jersey, has accepted Maintenance Bond #BX06807MB in the amount of \$217,123.10 from Think Pavers, 125 Kings Highway, Mount Royal, NJ 08061 for Project #08-18-T-385.i.
