**RESOLUTION AWARDING A (5) FIVE YEAR CONTRACT WITH OMNI RECYCLING, LLC,
PURSUANT TO N.J.S.A. 40A:11-5(s) FOR THE DISPOSAL OF THE TOWNSHIP OF
WASHINGTON'S RECYCLABLE MATERIALS**

WHEREAS, the Township of Washington intends to award a contract for the disposal of the Township of Washington's Recyclable Materials; and

WHEREAS, the Township of Washington, County of Gloucester, pursuant to N.J.S.A. 40A:11-5(s), may by resolution and without advertising for bids, contract for the disposal of Recycling Materials that have been transported to a Class A Recycling Center; and

WHEREAS, the current contract with Omni Recycling, LLC expires on March 31, 2021; and

WHEREAS, the Director of the Department of Municipal Services and the Purchasing Agent recommend the renewal of the contract with Omni Recycling, LLC due to the proximity of the location of the facility to the Township, other factors included; and

WHEREAS, the total cost for the Disposal of the Township of Washington's Recyclable Materials shall not exceed \$430,000.00 for budget year 2021 and subject to budgets adopted in subsequent years; and

WHEREAS, the Chief Financial Officer has certified that funds in the amount of \$430,000.00 are available in the 2021 budget line item #1-01-32-465-000-001, entitled Disposal & Marketing.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of the Washington, County of Gloucester, State of New Jersey that the Mayor is hereby authorized to enter into a (5) five-year contract with Omni Recycling, LLC, 408 Lambs Road, Pitman, New Jersey, 08071, effective April 1, 2021 through March 31, 2026, for the Disposal of the Township of Washington's Recyclable Materials, subject too review by the Township Solicitor.

BE IT FURTHER RESOLVED that a copy of the resolution be forwarded to the CFO, Administrator, Director of Municipal Services, and Vendor for their records.
