**RESOLUTION AWARDING A BID FOR 2021 PROPERTY MAINTENANCE SERVICES
TO TOP DOG MAINTENANCE, INC.**

WHEREAS, advertisement for bids for the provision of 2021 Property Maintenance Services was duly published in the South Jersey Times; and

WHEREAS, bids were received and opened on March 16, 2021 at 10:00 A.M.; and

WHEREAS, there were two (2) bids submitted as follows:

<u>Contractor</u>	<u>Base Bid Amount</u>
Top Dog Maintenance, Inc.	\$38.00 for lawn service / \$24.00 per hour
Rahn Landscaping, LLC	\$50.00 for lawn service / \$29.00 per hour

WHEREAS, the bid proposal of **Top Dog Maintenance, Inc.**, 3017 Delsea Drive, P.O. Box 158, Franklinville, NJ 08322, in the amount of \$38.00 for lawn care not to exceed one (1) acre is the lowest responsible bidder for the 2021 Property Maintenance Services; and

WHEREAS, additional costs, if needed, of \$24.00 per man hour for other property maintenance; and

WHEREAS, additional cost, if needed, of \$27.00 per cubic dumpster usage; and

WHEREAS, the award of the bid in the manner set forth above is necessary for the efficient operation of the Township of Washington; and

WHEREAS, the maximum amount is \$25,000.00 as directed by the Chief Financial Officer.


NOW, THEREFORE, BE IT RESOLVED by the Township of Washington the following:

1. **Top Dog Maintenance, Inc.**, 3017 Delsea Drive, PO Box 158, Franklinville, NJ 08322 is determined to be the lowest responsible bidder for 2021 Property Maintenance Services
2. The Mayor of the Township of Washington is hereby authorized to execute a contract with **Top Dog Maintenance, Inc.** in a form approved by the Solicitor of the Township of Washington.
3. The Chief Financial Officer has certified that funds are available to be drawn from Public Buildings Abandoned Property Maintenance, budget line item #0-01-26-310-000-061.
4. Notice of the contract award shall be published in the South Jersey Times.

BE IT FURTHER RESOLVED by the Council of the Township of Washington, in the County of Gloucester and State of New Jersey in accordance with the Local Public Contracts Law, N.J.S.A 40A:11-1 et seq, the contract is awarded to **Top Dog Maintenance, Inc.**

BE IT FURTHER RESOLVED that a copy of the resolution be forwarded to the CFO, Administrator, Qualified Purchasing Agent, Zoning Officer and Vendor for their records.
