**RESOLUTION AUTHORIZING AN AGREEMENT FOR GEESE CLEARING SERVICES  
AT WASHINGTON LAKE PARK**

**WHEREAS**, the Township of Washington's Department of Parks and Recreation has recommended that the Township hire a qualified company to provide safe and effective geese clearing and control services at Washington Lake Park; and

**WHEREAS**, the Township Council of the Township of Washington has determined that there is a need to retain a company that can provide these services to ensure the health and well-being of the residents of the Township; and

**WHEREAS**, the Township of Washington received a proposal for the necessary geese clearing services at Washington Lake Park from Geese Chasers, LLC, 4 Milton Drive, Medford, NJ 08055; and

**WHEREAS**, Geese Chasers, LLC will provide these services, with the use of working border collies, to the Township of Washington seven days per week (except national holidays) and more than one visit per day when needed during busy season, dawn until dusk as determined by Geese Chasers, LLC.; and

**WHEREAS**, pursuant to the applicable New Jersey State laws, the contract for these services may be authorized without public bidding since the total contract price will not exceed the public bidding threshold.

**WHEREAS**, the Chief Financial Officer has certified that funds are available in the 2021 budget line item #T-12-56-860-000-821, entitled Washington Lake Park.

**NOW, THEREFORE, BE IT RESOLVED**, that the Township Council of the Township of Washington does hereby authorize the proper official to execute and agreement with Geese Chasers, LLC for all necessary geese control and clearing services in accordance with the fee schedule set forth in their proposal.

**BE IT FURTHER RESOLVED**, that the Township Council of the Township of Washington does hereby authorize the Mayor and Municipal Clerk to execute any an agreement relating thereto.

**BE IT FINALLY RESOLVED**, that a copy of the resolution be forwarded to the CFO, Administrator, Department of Parks and Recreation, and the Township Clerk for their records.
