**RESOLUTION AUTHORIZING R. MOSLOWSKI EXCAVATING CHANGE ORDER NO. 1 FINAL AND
ACCEPTING A MAINTENANCE BOND FOR SHEFFIELD STORM SEWER RECONSTRUCTION,
PROJECT #08-18-T-384**

WHEREAS, R. Moslowski Excavating, Inc., 105 Merrick Road, Robbinsville, NJ 08691, was selected by Township Council in accordance with Resolution R050-2020 for Sheffield Storm Sewer Reconstruction, Project #08-18-T-384; and

WHEREAS, R. Moslowski Excavating, Inc., 105 Merrick Road, Robbinsville, NJ 08691 submitted a bid in the amount of \$222,222.00 and an agreement was signed by the Mayor; and

WHEREAS, Change Order No. 1 Final for Sheffield Storm Sewer Reconstruction was submitted by Township Engineer, Annina Hogan of Remington & Vernick, in a letter dated March 25, 2021 with a decrease of \$15,515.50, bringing the new total to \$206,706.50; and


WHEREAS, R. Moslowski Excavating, Inc. has submitted Maintenance Bond No. RU101257M in the amount of \$206,706.50 for Project #08-18-T-384.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Washington, County of Gloucester, and State of New Jersey that said Change Order No. 1 Final is approved and authorized for the new contractual total of \$206,706.50.

BE IT FURTHER RESOLVED, the Township Council of the Township of Washington, County of Gloucester, State of New Jersey, has accepted Maintenance Bond No. RU101257M in the amount of \$206,706.50 from R. Moslowski Excavating, Inc., 105 Merrick Road, Robbinsville, NJ 08691 for Project #08-18-T-384.
