**RESOLUTION AUTHORIZING LEXA CONCRETE CHANGE ORDER NO. 1 FINAL AND
ACCEPTING A MAINTENANCE BOND FOR 2019 ROAD PROGRAM, PHASE 3 – LONG BOW DRIVE,
PROJECT #08-18-T-392.I**

WHEREAS, Lexa Concrete, LLC, 11 Commerce Way, Hammonton, NJ 08037, was selected by Township Council in accordance with Resolution R161-2020 for 2019 Road Program, Phase 3 – Long Bow Drive, Project #08-18-T-392.I; and

WHEREAS, Lexa Concrete, LLC, 11 Commerce Way, Hammonton, NJ 08037 submitted a bid in the amount of \$545,890.06 and an agreement was signed by the Mayor; and

WHEREAS, Change Order No. 1 Final for 2019 Road Program, Phase 3 – Long Bow Drive was submitted by Township Engineer, Annina Hogan of Remington & Vernick, in a letter dated March 30, 2021 with additional charges of \$5,998.76 and a reduction of \$73,807.47; yielding a net decrease of \$67,808.71, bringing the new total to \$478,081.35; and

WHEREAS, Lexa Concrete, LLC, 11 Commerce Way, Hammonton, NJ 08037 has submitted Maintenance Bond #999067860 in the amount of \$478,081.35 for the project.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Washington, County of Gloucester, and State of New Jersey that said Change Order No. 1 Final is approved and authorized for the new contractual total of \$478,081.35.

BE IT FURTHER RESOLVED, the Township Council of the Township of Washington, County of Gloucester, State of New Jersey, has accepted Maintenance Bond #999067860 in the amount of \$478,081.35 from Lexa Concrete, LLC, 11 Commerce Way, Hammonton, NJ 08037 for Project #08-18-T-392.I.
