**RESOLUTION AWARDING A CONTRACT FOR PEDESTRIAN FLASHER IMPROVEMENTS AT
HURFFVILLE – CROSS KEYS ROAD AND WESTBURY DRIVE IN THE TOWNSHIP OF
WASHINGTON, PROJECT#08-18-T-398, TO GARDEN STATE HIGHWAY PRODUCTS, INC.,
301 RIVERSIDE DRIVE, MILLVILLE, NJ 08332**

WHEREAS, as requested by the Township, Remington & Vernick Engineers solicited quotes for the Township of Washington Pedestrian Flasher Improvements at Hurffville – Cross Keys Road and Westbury Drive Project #08-18-T-398; and

WHEREAS, three quotes were submitted by:

WHEREAS, the Engineer of the Township of Washington has determined that the quote from **Garden State Highway Products, Inc.**, 301 Riverside Drive, Millville, NJ 08332, in the amount of \$12,820.00 represents the lowest responsible quote; and

WHEREAS, in keeping with N.J.S.A. 40A:11-1 et seq., contracts should be awarded to the lowest responsible quote, which is Garden State Highway Products, Inc.; and


WHEREAS, the Engineer of the Township of Washington, in a letter dated February 18, 2021, recommends the award of the contract contingent upon approval by the Township Solicitor and monies being available; and

WHEREAS, the Chief Financial Officer has certified herein that funds are available in budget line item C-04-55-829-000-903 titled Various Stormwater Inlet and Road Repairs in the amount of \$9,274.00 and C-04-55-000-902 titled Erosion Concerns in the amount of \$3,546.00.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Township of Washington, in the County of Gloucester and State of New Jersey in accordance with the Local Public Contracts Law, N.J.S.A 40A:11-1et seq., the contract is awarded to **Garden State Highway Products, Inc.** based on the Engineer's letter dated February 18, 2021.

BE IT FURTHER RESOLVED that a copy of the resolution be forwarded to the CFO, Administrator, the Engineer, and the vendor for their records.


