**RESOLUTION AUTHORIZING AN EMERGENCY TEMPORARY APPROPRIATION OF FUNDS**

*WHEREAS*, an emergent condition has arisen with respect to costs as shown below and no adequate provision has been made in the 2021 temporary appropriations for the aforesaid purposes, and N.J.S.A. 40A:40-20 provides for the creation of an emergency temporary appropriation for the purposes above mentioned; and

*WHEREAS*, the total emergency temporary resolution in the year 2021 pursuant to the provisions of Chapter 96, P.L. 1951 (N.J.S.A. 40A:4-20) including this resolution total \$766,200.00.


