RESOLUTION AWARDING A CONTRACT FOR WAYNE AND WOODLAWN PATCHING IN THE TOWNSHIP OF WASHINGTON, PROJECT#08-18-T-399, TO PIONEER PIPE CONTRACTORS, 2682 GLASSBORO - CROSS KEYS ROAD, SEWELL, NJ 08080

WHEREAS, as requested by the Township, Remington & Vernick Engineers solicited quotes for the Township of Washington for Wayne and Woodlawn Patching, Project #08-18-T-399; and

WHEREAS, two quotes were submitted by:

Lexa Concrete, LLC	\$15,500.00

WHEREAS, the Engineer of the Township of Washington has determined that the quote from **Pioneer Pipe Contractors**, 2682 Glassboro - Cross Keys Road, Sewell, NJ 08080, in the amount \$14,575.00 represents the lowest responsible quote; and

WHEREAS, in keeping with N.J.S.A. 40A:11-1 et seq., the contracts should be awarded to the lowest responsible quote, which is Pioneer Pipe Contractors; and

WHEREAS, the Engineer of the Township of Washington, in a letter dated May 4, 2021, recommends the award of the contract contingent upon approval by the Township Solicitor and monies being available; and

WHEREAS, the Chief Financial Officer has certified herein that funds are available in budget line item C-04-55-829-000-902 titled Erosion Concerns in the amount of \$14,575.00.


