**RESOLUTION FOR CONDUCTING A PUBLIC HEARING FOR
THE ADOPTION OF THE 2021 MUNICIPAL BUDGET**

WHEREAS, the Washington Township 2021 Budget was presented to the Township Council by Mayor Gattinelli on April 28, 2021; and

WHEREAS, the 2021 Budget was accepted and introduced by Township Council on April 28, 2021; and

WHEREAS, the Summary of the 2021 Municipal Budget was published in the South Jersey Times on May 16, 2021 and posted on the Township of Washington Website; and

WHEREAS, a public hearing is required in keeping with the law; and

WHEREAS, the Business Administrator scheduled two public meetings on April 21, 2021 and April 22, 2021 for discussion by the Township Council and the general public to ask questions regarding the proposed 2021 Township of Washington Budget; and

WHEREAS, a public meeting was also conducted on May 26, 2021 for discussion by the Township Council and the general public of the 2021 Township of Washington Budget.


NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Washington, County of Gloucester, and State of New Jersey that a public hearing for the 2021 budget shall be held for funds for the purposes stated of the sums therein set forth as appropriations:
