**RESOLUTION APPROVING THE 2021 FIREWORKS DISPLAY AND AWARDING A CONTRACT
IN THE AMOUNT OF \$26,500.00 TO SCHAEFER FIREWORKS**

WHEREAS, the Township of Washington annually celebrates Independence Day at Washington Township High School with a celebration that includes a fireworks display; and

WHEREAS, the Township of Washington received quotes for the Washington Township Fireworks Display from **Schaefer Fireworks** in the amount of \$26,500 and **D& M Fireworks** in the amount of \$30,000; and

WHEREAS, the proposal for the July 4, 2021 fireworks display from **Schaefer Fireworks**, 370 Hartman Bridge Road, Ronks, PA 17572, in the amount of \$26,500.00, is determined to be the lowest quote received.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Washington, County of Gloucester and State of New Jersey that:

1. The Mayor is authorized to sign a contract with **Schaefer Fireworks Companies**, 370 Hartman Bridge Road, Ronks, PA 17572, on behalf of the Township of Washington, contingent upon the review and approval of the Township Solicitor. Refer to attached Exhibit "A".
3. The CFO has certified that funds in the amount of \$26,500 are available in the 2021 budget in line item #1-01-30-420-000-092, entitled Celebrating Public Events Fireworks.
4. Notice of the contract award shall be published in the South Jersey Times.

BE IT FURTHER RESOLVED, by the Council of the Township of Washington, in the County of Gloucester and State of New Jersey in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11 et seq, the contract is awarded to **Schaefer Fireworks**.

BE IT FURTHER RESOLVED, that the Township Council of the Township of Washington, County of Gloucester, State of New Jersey hereby approves the Fireworks display being held at Washington Township High School on July 4, 2021, with a rain date of July 5, 2021.

BE IT FINALLY RESOLVED, a copy of this Resolution shall be provided to the CFO, Business Administrator, Events Coordinator, the Vendor, and the Township Clerk for their records.


