**RESOLUTION AWARDING A BID FOR THE 2020 ROAD PROGRAM - PHASE I
TO PAVING PLUS, LLC, PROJECT #08-18-T-398**

WHEREAS, advertisement for bids for the 2020 Road Program – Phase I, Project #08-18-T-398, was duly published in the South Jersey Times; and

WHEREAS, bids were received and opened on Wednesday, June 2, 2021 at 10:00 A.M.; and

WHEREAS, there were six (6) bids submitted as follows:

WHEREAS, the bid proposal of **Paving Plus, LLC**, 120 Grove Street, Franklinville, NJ 08322 in the amount of \$307,133.35 is the lowest responsible bidder for 2020 Road Program – Phase I, Project #08-18-T-398; and

WHEREAS, Remington & Vernick, the Engineer of the Township of Washington, in a letter dated June 7, 2021 recommends the award of the contract contingent upon approval by the Township Solicitor and funds being available.


NOW, THEREFORE, BE IT RESOLVED, by the Township of Washington the following:

1. **Paving Plus, LLC**, 120 Grove Street, Franklinville, NJ 08322 is determined to be the lowest responsible bidder for the 2020 Road Program – Phase I.
2. The Mayor of the Township of Washington is hereby authorized to execute a contract with Paving Plus, LLC in a form approved by the Solicitor of the Township of Washington.
3. The Chief Financial Officer has certified that funds are available to be drawn from budget line item C04-55-837-000-901, 2020 Capital Bond Road Program.
4. Notice of the contract award shall be published in the South Jersey Times.

BE IT FURTHER RESOLVED by the Council of the Township of Washington, in the County of Gloucester and State of New Jersey in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq, the contract is awarded to **Paving Plus, LLC**.

BE IT FINALLY RESOLVED that a copy of the resolution be forwarded to the CFO, Administrator, Qualified Purchasing Agent, Professional and Vendor for their records.


