RESOLUTION AWARDING A CONTRACT FOR SOLID WASTE AND RECYCLING
COLLECTION BEGINNING AUGUST 1, 2021 AND ENDING JULY 31, 2024

WHEREAS, advertisement for bids for the provision of services for Solid Waste and Recycling Collection was duly published in the Newark Star-Ledger and the South Jersey Times; and

WHEREAS, bids were received and opened on June 18, 2021 at 10:00 A.M.; and

WHEREAS, the following bid was received for a three-year contract:

Gold Medal Environmental of NJ	\$11,424,955.68	\$3,808,318.56

WHEREAS, the bid proposal of Gold Medal Environmental of N.J., Inc., 309 Salina Road, Sewell, NJ 08080 in the amount of \$11,424,955.68 for a three-year contract is the lowest responsible bid; and

WHEREAS, the award of the bid in the manner set forth above is necessary for the efficient operation of the Township of Washington.

NOW, THEREFORE, BE IT RESOLVED by the Township of Washington as follows:


1. The Mayor is authorized to sign a contract with Gold Medal, 309 Salina Road, Sewell, NJ 08080, on behalf of the Township of Washington, contingent upon the review and approval of the Township Solicitor.
2. The contract period shall be from August 1, 2021 to July 31, 2024 not to exceed \$11,424,955.68.
3. The CFO has certified that funds are available in the 2021 budget in line item #1-01-26-305-000-001, entitled Trash Collection and subject to budgets adopted in subsequent years; and
4. Notice of the contract award shall be published in the South Jersey Times.

BE IT RESOLVED, this resolution was adopted at a meeting of the Township Council of the Township of Washington held on June 23, 2021 and shall take effect immediately.
