**RESOLUTION AWARDING A CONTRACT FOR THE UPFIT AND LABOR OF FIFTEEN (15) NEW
POLICE INTERCEPTOR UTILITY VEHICLES FOR THE POLICE DEPARTMENT**

WHEREAS, the Township of Washington intends to participate in the New Jersey State Purchasing Contract 17-FLEET-00748 with EAI, 770 Cuthbert Boulevard, Cherry Hill, New Jersey 08002 for the upfit and labor of fifteen (15) police interceptor utility vehicles; and

WHEREAS, the Township of Washington, in the County of Gloucester, pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:34.7.29(c), may by resolution, and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State Contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, EAI, 770 Cuthbert Boulevard, Cherry Hill, New Jersey 08002 has been awarded the upfit and labor for fifteen (15) police interceptor utility vehicles; and

WHEREAS, the total cost to upfit and labor cost for fifteen (15) police interceptor utility vehicles is \$282,260.65; and

WHEREAS, the Chief Financial Officer has certified that funds are available in the 2021 Capital Budget line item #C-04-55-838-000-906, entitled Various Police Vehicles & Equipment.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Washington, County of Gloucester, State of New Jersey that EAI, 770 Cuthbert Boulevard, Cherry Hill, New Jersey 08002, is hereby awarded the upfit and labor for the purchase of fifteen (15) new police interceptor utility vehicles.
