**RESOLUTION AUTHORIZING CHANGE ORDER NO. 1 AND ACCEPTING A MAINTENANCE BOND
FROM COMMAND CO., INC. FOR CEDAR LAKE OPEN SPACE IMPROVEMENTS,
PROJECT #08-18-T-374.I**

WHEREAS, Command Co., Inc., 1318 Antwerp Avenue, Egg Harbor City, NJ 08215, was selected by Township Council in accordance with Resolution R123-2020 for the Cedar Lake Open Space Improvements, Project #08-18-T-374.I; and

WHEREAS, Command Co., Inc., 1318 Antwerp Avenue, Egg Harbor City, NJ 08215 submitted a bid in the amount of \$986,739.70 and an agreement was signed by the Mayor; and

WHEREAS, Change Order No. 1 Final for the Cedar Lake Open Space Improvements was submitted by Township Engineer, Annina Hogan of Remington & Vernick, in a letter dated July 7, 2021 with additional charges of \$20,827.40, a reduction of \$133,099.09 and supplementals in the amount of \$118,284.40; yielding a net increase of \$6,012.71, bringing the new total to \$992,752.41; and

WHEREAS, Command Co., Inc., 1318 Antwerp Avenue, Egg Harbor City, NJ 08215 has submitted Maintenance Bond #HICNE-10-239-0769M in the amount of \$992,752.41 for the project.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Washington, County of Gloucester, and State of New Jersey that said Change Order No. 1 Final is approved and authorized for the new contractual total of \$992,752.41.


