**RESOLUTION APPROVING LARGE GATHERING APPLICATION FOR
THE WASHINGTON TOWNSHIP ROTARY CLUB**

WHEREAS, Washington Township Rotary Club, P.O. Box 601, Turnersville, NJ 08012 has made application for a wine festival to be held at Washington Lake Park, 626 Hurffville-Cross Key Road, Sewell, New Jersey on Saturday, September 18, 2021 from 12:00 p.m. to 5:00 p.m., rain date Saturday, September 19, 2021 from 12:00 p.m. to 5:00 p.m.; and

WHEREAS, Washington Township Rotary Club is a non-exempt entity and therefore, exempt from all fees under Township Ordinance 44-1, etc.; and

WHEREAS, each vendor who participates in the Wine Festival submits a copy of their Wine Festival Permit issued by the New Jersey Alcoholic Beverage Control, a Hold Harmless Agreement, and a Certificate of Insurance naming Washington Township as an additional insured; and

WHEREAS, Washington Township Rotary Club shall gather all documents for the Festival and submit them one week prior to the Township of Washington; and

WHEREAS, Washington Township Rotary Club has requested a special permit be issued in compliance with the Township Ordinance 11-21 by the Township of Washington Council; and

WHEREAS, the Township of Washington Events Department has successfully worked closely with the Washington Township Rotary Club in the past; and

WHEREAS, the event promotes Washington Township and provides an economic opportunity for merchants and residents participation.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Washington, County of Gloucester, and State of New Jersey that the \$100 fee and \$100 cash bond is waived.

BE IT FURTHER RESOLVED that the Application for Large Gathering is approved contingent upon receipt of each vendor's Certificates of Insurance naming Washington Township as an additional insured for the amounts required by TRICO JIF, a Hold Harmless Agreement, a copy of the Wine Festival Permit received from the State of New Jersey Alcoholic Beverage Control, and

coordination of appropriate security measures and public works put into effect as well, by Washington Township Rotary Club, P.O. Box 601, Turnersville, NJ 08012.

BE IT FINALLY RESOLVED a copy of this Resolution is to be provided to the Township Municipal Event Department, Administrator, CFO, and the vendor.
