**RESOLUTION AUTHORIZING CHANGE ORDER NO. 1 AND ACCEPTING A MAINTENANCE BOND  
FROM GWP ENTERPRISES, INC. FOR THE 2019 ROAD PROGRAM PHASE II,  
PROJECT #08-18-T-392**

**WHEREAS**, GWP Enterprises, Inc., 4344 Tuckahoe Road, Williamstown, NJ 08094, was selected by Township Council in accordance with Resolution R134-2020 for the 2019 Road Program Phase II, Project #08-18-T-392; and

**WHEREAS**, GWP Enterprises, Inc., 4344 Tuckahoe Road, Williamstown, NJ 08094 submitted a bid in the amount of \$904,546.90 and an agreement was signed by the Mayor; and

**WHEREAS**, Change Order No. 1 Final for the 2019 Road Program Phase II was submitted by Township Engineer, Annina Hogan of Remington & Vernick, in a letter dated August 11, 2021 with a reduction in the amount of \$109,027.71, bringing the new total to \$795,519.19; and

**WHEREAS**, GWP Enterprises, Inc., 4344 Tuckahoe Road, Williamstown, NJ 08094 has submitted Maintenance Bond #ASA1783-12730MNT in the amount of \$795,519.19 for the project.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Washington, County of Gloucester, and State of New Jersey that said Change Order No. 1 Final is approved and authorized for the new contractual total of \$795,519.19.




