**RESOLUTION AUTHORIZING CHANGE ORDER NO. 1 AND ACCEPTING A MAINTENANCE BOND
FROM PAVING PLUS, LLC FOR 2019 ROAD PROGRAM – HARTFORD ROAD,
PROJECT #08-18-T-392.I**

WHEREAS, Paving Plus, LLC, P.O. Box 508, Franklinville, NJ 08322, was selected by Township Council in accordance with Resolution R196-2020 for the 2019 Road Program – Hartford Road, Project #08-18-T-392.i; and

WHEREAS, Paving Plus, LLC, P.O. Box 508, Franklinville, NJ 08322 submitted a bid in the amount of \$506,005.50 and an agreement was signed by the Mayor; and

WHEREAS, Change Order No. 1 Final for the 2019 Road Program – Hartford Road was submitted by Township Engineer, Annina Hogan of Remington & Vernick, in a letter dated August 17, 2021 with a reduction in the amount of \$38,902.15, bringing the new total to \$467,103.35; and


WHEREAS, Paving Plus, LLC, P.O. Box 508, Franklinville, NJ 08322 has submitted Maintenance Bond #ASA1783-12946MNT in the amount of \$467,103.35 for the project.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Washington, County of Gloucester, and State of New Jersey that said Change Order No. 1 Final is approved and authorized for the new contractual total of \$467,103.35.


