**RESOLUTION AWARDING A CONTRACT FOR THE TOWNSHIP OF WASHINGTON
VARIOUS ROAD STRIPING IMPROVEMENTS, PROJECT#08-18-T-399,
TO ZONE STRIPING, P.O. BOX 568, GLASSBORO, NJ 08028**

WHEREAS, as requested by the Township, Remington & Vernick Engineers solicited quotes for Various Road Striping Improvements in the Township of Washington, Project #08-18-T-399; and

WHEREAS, quotes were due to be received by June 18, 2021; and

WHEREAS, a quote was submitted by Zone Striping, P.O. Box 568, Glassboro, NJ 08028 in the amount of \$8,937.40; and

WHEREAS, the Engineer of the Township of Washington has determined that the quote proposal from Zoning Striping, P.O. Box 568, Glassboro, NJ 08028, in the amount \$8,937.40 represents the lowest responsible quote; and

WHEREAS, in keeping with N.J.S.A. 40A:11-1 et seq., the contracts should be awarded to the lowest responsible quote, which is Zone Striping; and

WHEREAS, the Engineer of the Township of Washington, in a letter dated June 28, 2021, recommends the award of the contract contingent upon approval by the Township Solicitor and monies being available; and

WHEREAS, the Chief Financial Officer has certified herein that funds are available in budget line item C04-55-838-000-901 titled 2021 Road Program.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Township of Washington, in the County of Gloucester and State of New Jersey in accordance with the Local Public Contracts Law, N.J.S.A 40A:11-1et seq., the contract is awarded to Zone Striping based on the Engineer's letter dated June 28, 2021.

BE IT FURTHER RESOLVED that a copy of the resolution be forwarded to the CFO, Administrator, the Engineer, and the vendor for their records.
