**WHEREAS**, as requested by the Township, Remington & Vernick Engineers solicited quotes for Driver Feedback Poles and Foundations in the Township of Washington, Project #08-18-T-399; and

**WHEREAS**, quotes were due to be received by August 13, 2021; and

**WHEREAS**, a quote was submitted by Garden State Highway Products, Inc., 301 Riverside Drive, Millville, NJ 08332 in the amount of \$13,410.00; and

**WHEREAS**, the Engineer of the Township of Washington has determined that the quote from Garden State Highway Products, Inc., 301 Riverside Drive, Millville, NJ 08332, in the amount \$13,410.00 represents the lowest responsible quote; and

**WHEREAS**, in keeping with N.J.S.A. 40A:11-1 et seq., the contracts should be awarded to the lowest responsible quote, which is Garden State Highway Products, Inc.; and

**WHEREAS**, the Engineer of the Township of Washington, in a letter dated August 26, 2021, recommends the award of the contract contingent upon approval by the Township Solicitor and monies being available; and

**WHEREAS**, the Chief Financial Officer has certified herein that funds are available in budget line item C04-55-837-000-906 titled Police Capital Bond Vehicles and Equipment.


