**RESOLUTION AWARDING A CONTRACT FOR THE PURCHASE OF THREE
2022 CHEVROLET COLORADO 4WD VEHICLES FOR THE DEPARTMENT OF PUBLIC WORKS
THROUGH SOURCEWELL COOPERATIVE PRICING SYSTEM**

WHEREAS, the Township of Washington intends to purchase three (3) 2022 Chevrolet Colorado 4WD vehicles through Sourcewell Cooperative Pricing System Contract #120716-NAF for the Department of Public Works; and

WHEREAS, the Township of Washington, County of Gloucester, pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:34.7.29(c), may, by resolution and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State Contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, the total cost of equipment and delivery is \$80,650.03; and

WHEREAS, the Chief Financial Officer has certified that funds in the amount of \$80,650.03 are available in the 2021 budget line item #C-04-55-838-000-904, entitled Various Public Works Vehicles and Equipment.


